Uniforms

New rowers must purchase a uni (uniform) and will be measured before the season begins.

Payments will be due in February; checks should be made out to: Wappingers Crew Club.

Equipment Fee

Each rower is responsible for \$100.00 for the equipment fee.

If there are 2 or more rowers from the same family the total amount due is \$150.00.

Equipment fee obligation can be met in several ways.

Option 1 - *Pay full amount due by cash or check.*

Option 2 – *Raise the equipment fee by fundraising through the following ways:*

Candy sales, erg-a-thon or duck race raffle tickets.

NOTE: *Equipment fee is due by March 31st of the rowing season.*

Option 2 – *Payment in full by credit card at time of Registration only. (There is a 3.5% fee added for this option)*

Club Payment Options (cont'd)

If rower's dues are not paid in full by February 2nd of the rowing season, your child will not be allowed to participate in practices or races until payment is made. This also applies to the equipment fee that is due on March 31st.

All registration paperwork needs to be submitted by February 2nd or rowers will not be allowed to participate in tryouts.
